Subject: Scheme of Examination of the Recruitment Process for candidates found Eligible/provisionally Eligible for Faculty positions

1. Reference is made to the advertisement no: NIDMP/HR/Rectt-Faculty & Tech/02/2020 dated 17.04.2020, for the posts of Senior Technical Instructor, Senior Design Instructor, Principal Technical Instructor, Designer/Faculty, Senior Faculty/Designer (Associate Professor) and Associate Senior Designer (Assistant Professor).
2. Candidates who had applied for various Faculty positions in response to the above cited advertisement and considered Eligible/Provisionally Eligible are requested to check the schedule notified on the institute website. The details of the scheme of Examination of the Recruitment Process for candidates found Eligible/provisionally Eligible for Faculty positions are given below.
3. Mode of Selection: The Mode of Selection will be as follows:-
 - (i) The Eligible/Provisionally Eligible Candidates shall be required to appear for an Online Screening Test (except candidates appearing for the post of Principal Technical Instructor, for whom the Screening Test shall be conducted in physical/offline mode at NID MP campus and the result for the Test shall be announced preferably on the same day).
 - (ii) Candidates who have applied for posts having more than one vacancy/competency, were asked by the Institute to submit their preference out of the available competencies, wherever applicable, and shall accordingly be given the choice of attempting the respective question paper on the basis of their preference. However, no candidate shall be permitted to appear for more than one competency/question paper for the same post. The instructions for the candidates appearing in the screening test shall be forwarded to the candidates by email.
 - (iii) The list of candidates qualifying the Screening Test, shall be uploaded on the Institute Website (preferably within a week of conduct of the Screening Tests) and these shall be eligible to appear for the Interview, subject to their successfully completing the document verification process.
 - (iv) The document verification process and the Interview shall be conducted at the NID MP Campus and the tentative schedule for the same has already been notified on the NID MP website vide Notification No. 03/2021 dated 25.08.2021.
 - (v) The candidates eligible to appear for the document verification process/ Interview shall have to make their own arrangement for stay.

(vi) The candidates appearing for the document verification process shall have to bring all relevant documents/certificates in original as well as 01 set of self-attested photocopies, as applicable and stated by them in their application form/representation requests, failing which they shall not be allowed to appear for the interview process.

(vii) The Interview Assessment Sheet shall be uploaded on the Institute Website for the information of the candidates.

(viii) The final result shall be displayed on the Institute Website for each post.

(ix) Success in the examination confers no right of appointment unless the Institute is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respects of appointment to the service/post.
